第一條（修業年限）

修業及休學年限：依本校學則規定辦理。

Article 1 Time Limit for Graduation and Suspension from School

The periods of study shall be as stipulated in the Taipei Medical University Academic Regulations.

第二條（修業學分及畢業門檻）

修業學分：須修畢至少34學分，包括必修22學分(含碩士論文6學分)及至少選修12學分。碩士班研究生得選修本校其他系所相關課程，須經指導教授同意依研究領域需求修習，最多採計6學分。

Article 2 Course Requirements

The student who matriculated is required to complete a minimum of 34 credits, including 22 required credits (6 credits from Thesis, 4 credits from Seminar and 0 credit from Research ethics) and take a minimum of 12 elective credits. Students can take up to 6 elective credits from other institutes or programs where approved

by their advisor.

第三條（論文指導教授）

指導教授：每位碩士班研究生必須於第一學年第二學期結束(七月三十一日)前繳交指導教授同意函。研究生如欲變更指導教授必須於第二年第一學期結束前提交更換指導教授意願書，經所務會議通過後始得更換。

Article 3 Advisor

Every Master graduate student is obliged to submit thesis advisor agreement by the end of the second semester of the first year.

Students who wish to change their advisor must submit their application by the end of the first semester of the second year.

第四條（學位考試）

學位考試：

- (一)依本校行事曆規定時間內提出申請。
- (二)研究生應經指導教授核定後提交論文初稿及摘要做為學位考試申請。
- (三)完成研究生學術學習護照 36 小時時數認證文件。
- (四)碩士學位考試委員三至五人，其中校外委員以三分之一為限，且指導教授及共同指導教授之外委員應過半，由指導教授建議名單，呈所長圈選並指定一人為召集人，指導教授及共同指導教授不得擔任召集人。
- (五)學位考試成績，以出席委員無記名投票之平均分數決定之；投票以一次為限。評分超過(或等於)七十分方為及格，碩士學位考試有二分之一以上委員評定為不及格者，即以不及格論。考試不及格者則依本校碩士及博士學位考試實施細則規定辦理。
- (六)考試通過後，研究生需彙整委員意見及修改論文。碩士論文經修改後必須取得出席委員審查核可；研究生需依本校考試審查流程及畢業離校程序辦理得予核發學位證書。

Article 4 Oral Thesis Defense (OTD)

- (1) Applications should be done in accordance to the University

Calendar.

(2) Students may submit their thesis abstract and draft to the GIMBC Director when given approval to do so by their advisor. Submission of this draft will be taken as their application for their OTD.

(3) Get the certificate of 36 hours from TMU Research and Learning Passport.

(4) The Oral Thesis Defense Committee consists of three to five members. Non-TMU faculty cannot be more than one third of committee. The Advisor and co-Advisors cannot form more than half of the committee. Potential members of the Committee are recommended by the student's Advisor, then elected by the GIMBC Director. The GIMBC Director also elects one member to be Convener. Advisor and co-Advisors cannot be the Convener of the OTD Committee.

(5) An average score of those given by the OTD Committee members will be used. Scores will be given by the committee once only. Students with an average score $\geq 70\%$ will be permitted to submit their thesis pending approval of the revisions required by the committee. Where more than half of the committee give a score lower than 70% the student will not be permitted to submit their thesis at this point. Resubmission of a thesis that does not pass at this stage is per university regulations.

(6) Students who have passed the OTD are obliged to submit all certificate documents to GIMBC and revise their Thesis in accordance with the suggestions of OTD Committee. Revisions must be approved by the members of the original committee. The student should then submit the final, approved version of their Thesis to TMU, and complete administrative procedures according to University regulations, for Master's degree certification.

第五條（未盡事宜）

其他未盡事宜，悉依教育部與本校相關規定辦理。

Article 5 Regulations not mentioned here should be handled according to regulations of Ministry of Education and TMU.

第六條（核決權限）

本規定經教務會議通過，報請校長公告後施行；修正時亦同。

Article 6 This guideline has been implemented after being passed at the Institute Affairs Meeting, College Affairs Meeting, and Academic Affairs Meeting, and after approval by the principal. The same conditions apply in the event of amendments.
